Alliance Defending Freedom, The Legal Organization Litigating 303 Creative v. Elenis, Received A Massive Boost In Funding In 2021– Funding Anti-Democracy Allies And Their Legal Crusade To Push An Anti-LGBTQ Agenda In The Name Of "Freedom"

Summary: The **Alliance Defending Freedom (ADF)** <u>litigated</u> the 303 Creative LLC v. Elenis Supreme Court case on behalf of the plaintiffs challenging anti-discrimination protections. The case threatens to undo "decades of civil rights protections" by allowing businesses to announce their intent to <u>discriminate against LGBTQ people</u>. 303 Creative LLC v. Elenis is part of a strategy spearheaded by ADF and is expected to be decided by the <u>court in June</u> 2023.

Alliance Defending Freedom is a <u>recognized anti-LGBTQ hate group</u> that is the backbone of a right-wing "<u>legal army</u>" that works to push <u>unpopular anti-LGBTQ</u> and <u>anti-abortion agendas</u> through legal means. ADF also pushed its unpopular agenda by urging its supporters to support <u>restrictive voter suppression laws</u> in the wake of the <u>2020 election</u> and the rise of anti-democratic "election integrity" actors.

While ADF claimed that the *303 Creative case* is about "<u>freedom</u>" and "censorship," the organization uses these terms to further its anti-LGBTQ agenda. <u>In 2021</u>, ADF experienced a massive spike in funding, **reporting nearly \$105 million in total revenue**– <u>almost \$30 million more than its 2020 total</u>. ADF used its newfound wealth to fund anti-democratic organizations to support their unpopular, discriminatory agenda and **law firms that filed cases with ADF**. In 2021, ADF granted the following:

- \$85,000 to the Child & Parental Rights Campaign: An anti-trans group affiliated with Alliance Defending Freedom that <u>filed lawsuits challenging</u> gender-affirming policies in Florida schools. Its president, Vernadette Broyles, who <u>once compared</u> LGBTQ people to cockroaches, advised anti-trans legislation in <u>South Dakota and Georgia</u>.
- **\$84,183 to the Family Foundation of Virginia**: A group that <u>challenged</u> <u>gender-affirming</u> education guidelines <u>in Virginia</u> and endorsed a gubernatorial candidate in the state who said that her support of the "<u>patriots</u>" who stormed the Capitol on January 6, 2021, was a "badge of honor."
- \$78,000 to the Ethics and Public Policy Center: An organization that filed an amicus brief supporting ADF in <u>303 Creative LLC v. Elenis</u>. The group also filed amicus briefs in support of ADF cases that <u>challenged a ban</u> on <u>LGBTQ conversion therapy</u> and the FDA's <u>approval of medication abortion drug Mifepristone</u>. <u>Conservative kingpin</u> Leonard Leo, who uses his judicial influence to <u>push unpopular policies</u>, is a <u>board</u> <u>member</u> at the Ethics and Public Policy Center.
- \$50,000 to County Citizens Defending Freedom USA: A group founded in 2021 that pushes for bans on LGBTQ books in Florida schools and pressures local election

officials to launch "<u>election integrity</u>" initiatives rooted in false claims that drive a <u>partisan campaign to interfere</u> with independent elections.

- **\$50,000 to the Women's Liberation Front**: A group previously receiving funding from ADF to <u>fight against trans rights</u>. The Women's Liberation Front filed an <u>amicus brief</u> in an ADF case that <u>challenges the firing</u> of a Virginia teacher who refused to use a student's preferred pronouns.
- **\$42,396 to Cooper & Kirk PLLC**: A law firm <u>representing</u> the petitioners in *Foundations For Individual Rights In Education v. Victims Rights Law Center*, a Supreme Court case that <u>challenged Title IX's sexual harassment policies</u>. ADF filed an <u>amicus brief</u> in support of the petitioners in that case.
- **\$25,000 to Mauck & Bake** and **\$19,500 to Dalton & Tomich**: Law firms that worked a case with ADF and won a <u>\$370,000 settlement</u> for a healthcare worker in Illinois that sued her county government for mandating training that included information on abortion referral services.
- **\$30,000 to Kriegshauser Ney Law Group**: A law firm that <u>litigated a case</u> with ADF and won a <u>\$95,000 settlement</u> for a Kansas public school teacher who refused to use a student's preferred pronouns.
- **\$30,000 to Hixon & Brown**: A law firm that <u>litigated a lawsuit</u> with ADF that accused Planned Parenthood of intentionally miscoding abortion services to commit Medicaid fraud.
- **\$28,042 to Smith Appellate Law Firm**: A firm that filed a motion with ADF to protect a <u>potential abortion ban</u> in Michigan and <u>represented a plaintiff</u> in ADF's case that challenged the FDA's <u>approval of medication abortion drug Mifepristone</u>.
- **\$27,387 to the Charlotte Lozier Institute**: A group that <u>filed an amicus brief</u> supporting ADF's case that challenged the FDA's <u>approval of medication abortion drug</u> <u>Mifepristone</u>.
- **\$25,000 to the American Association of Pro-Life Obstetricians and Gynecologists**: A group that <u>ADF represented</u> in its case that challenged the FDA's approval of medication abortion drug Mifepristone.
- **\$20,928 to Frontline Policy Council**: A <u>partner of ADF</u> that launched a "<u>parental</u> <u>rights initiative</u>" in Georgia with assistance from ADF. The initiative targeted LGBTQ-affirming school policies and 'critical race theory.'
- **\$16,766 to Smith Haughey Rice & Roegge**: A law firm that filed a motion with ADF to protect a <u>potential abortion ban</u> in Michigan.
- **\$11,430 to the Religious Freedom Institute**: An organization that works in <u>coalition</u> <u>with ADF</u> and works to pass "<u>license to discriminate</u>" legislation that allows healthcare workers to deny services to LGBTQ or abortion-seeking persons.

\$8,608 to Spero Law LLC: A Law firm that assisted ADF in multiple cases. Spero Law filed an <u>amicus brief</u> in support of an ADF case that challenged a ban on <u>discriminatory hiring practices</u>, served as counsel <u>alongside ADF</u> in a case that aims to <u>uphold a ban</u> on gender-affirming care in Alabama, and <u>filed amicus briefs</u> alongside ADF in a case that challenged a court order for a University to <u>recognize an on-campus Pride Alliance</u>.

In July 2021, the U.S. Court of Appeals for the Tenth Circuit ruled against Lorie, holding that Colorado can force her to create websites promoting messages that contradict her beliefs about marriage. Chief Judge Tymkovich wrote a powerful dissent, calling the majority's holding "unprecedented" and "staggering," stating that "[t]the Constitution protects Ms. Smith from the government telling her what to say..." She appealed to the Supreme Court of the United States on September 24, 2021, and the Court granted her petition for review on February 22, 2022. Oral arguments are expected this fall.

303 Creative LLC v. Elenis Is Part Of A "Nationwide Experimental Legal Strategy Spearheaded By The [Alliance Defending Freedom]." "303 Creative is not stand-alone litigation. Rather, it is part of a nationwide experimental legal strategy spearheaded by the ADF to advance a broader anti-LGBTQ project. The strategy is aggressive and preemptive, as I have documented in my research on the group's methods leading up to Smith's case. The ADF seeks to secure an advance judicial permission to engage in what is currently forbidden after the fact: refusals to transact with LGBTQ parties. In a wave of preemptive proceedings, the organization represents businesses owned by devout Christians who declare an intention to refuse to deal with LGBTQ couples in the context of marriage. The Child & Parental Rights Campaign Filed Two Lawsuits Challenging Gender Affirming Policies In Florida In Late 2021 And Early 2022. "The Child and Parental Rights Campaign filed the suit on behalf of the parents in federal court. Child and Parental Rights Campaign, Inc. (CPR-C) is a non-partisan, non-profit public interest law firm whose mission is to defend parental rights and protect children's well-being against the impacts of gender identity ideology. The group recently filed a lawsuit against Leon County school officials related to allegations that a middle school student was put through a gender transition plan without parental notification. In that case, there was school guidance that indicated minor students did have a right to privacy. Leon County Schools Superintendent Rocky Hanna has since changed the guidance." Slate Referred To The Child & Parental Rights Campaign As A "A Thinly Veiled Anti-Trans Organization Affiliated With The Alliance Defending Freedom." "In Florida, anti-LGBTQ forces are trying more direct measures. Over the past few months, two lawsuits were filed in Florida by the Child & Parental Rights Campaign, or CPR-C, seeking to implement forced outing through litigation. These lawsuits seek to require school staff to out students by reporting to parents if a student has gender dysphoria or is questioning their gender. Parental Rights Campaign, urged him to raise the age threshold to 18. [...] In October 2019, Broyles announced to the group that she and Robbins had met with Georgia state Rep. Ginny Ehrhart and converted her to their cause. 'She is filing our bill this legislative session,' Broyles wrote. 'Am stoked for what God is doing in Georgia.' Not long after their meeting, the Atlanta Journal Constitution reported Ehrhart as saying she had drafted the bill in response to a high-profile child custody dispute in the Texas, in which parents disagreed about their child's gender identity." At the October 9 summit, Broyles: compared LGBTQ advocates to insects, claiming LGBTQ-inclusive school policies are 'passed in the dark" and 'there's a reason why cockroaches like the dark" [Media Matters, <u>10/15/19</u>]
- Broyles Filed A Lawsuit In 2018 Attempting To Overturn A Gender-Affirming Bathroom Policy In Georgia.
